## Instructions for Payment

<u>Instructions to the Green-Star Auditor or Company Personnel:</u> Use the attached invoice to request the appropriate payment from the company's accounts payable department who have completed an inspection on their Ready Mixed Concrete Production Facilities

Payment can be sent from the Green-Star Auditor (on behalf of the company) or the company requesting certification.

<u>Checks:</u> The Green-Star Auditor must complete the appropriate section of the attached payment form and submit the payment form to the company being inspected. Note: The processed check must accompany the Green-Star Facility Certification Application when submitted to the NRMCA. Checks should be made payable to NRMCA.

<u>Credit Cards:</u> NRMCA accepts American Express, Master Card and Visa for payment. The entity making the payment should complete the credit card section of the invoice and include this form of payment with the Green-Star Facility Certification Application when submitted to NRMCA.
